

Configuration

- Option 1: Configuration via TempSen Express Software

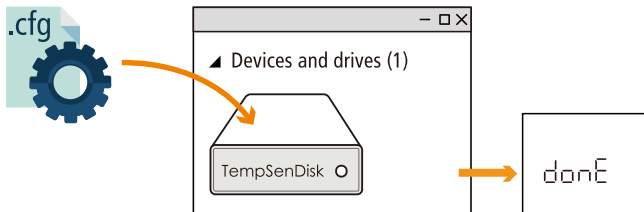
Connect logger to PC, open TempSen Express software, select configuration profile you need and click "Configure Device".

- Option 2: Online Configuration

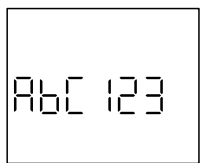
Connect data logger to PC via USB connection, open online configuration portal <https://ou-itag.tempsen.com/> in internet browser, then select the device you are going to configure, input configuration parameters, download configuration profile (.cfg format) and save it to the logger created Removable Storage Device "TempSenDisk". Logger LCD shows "donE" (Done) after successful configuration.



- After Configuration



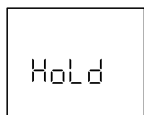
After successful configuration, remove logger from USB port, logger LCD should display "rEAdy" (Ready), means logger is ready for being started for new recording.



Logger LCD will display custom Profile ID number in stead of "rEAdy" if Profile ID was set.

← Profile ID "ABC123"

Start Recording



Press and hold (Start/Stop) button for 3 seconds to start logger, "Hold" on LCD reminds user to keep current button action, until **REC** appears on LCD.



If logger was set to a start delay, logger LCD will show countdown of start delay time after logger was started, and recording will begin after start delay passed.

← 30 minutes count down, recording will begin after 30 minutes

If logger was set to "Auto Start", logger LCD will show a countdown to preset start time after configuration, no need to start logger manually.

Stop Recording

Press and hold (Start/Stop) button until **StoP** (Stop) appears on home screen to stop recording.

- You could disable **Stop** button during configuration
- ITAG4 logger could not be stopped by pressing button within 30 minutes after recording began.



If logger's stop button was disabled or you try to stop a logger within 30 minutes from recording started, LCD will show "NoStoP" (No Stop) to remind you that recording could not be stopped by pressing button.

Download Data

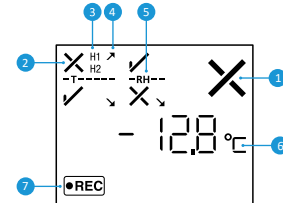
Connect data logger to USB port, logger will generate a PDF data file in removable storage device **TempSenDisk** in seconds, you could simply copy PDF report to your computer.

You could also download device using TempSen Express software.

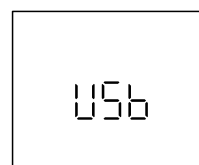

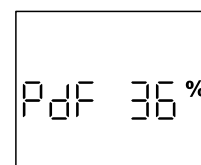
- ¹Limit violated indicator shows when temperature exceeded any high or low alarm limits
- ²Humidity sensor only applicable to ITAG[®] 4 TH

Logger LCD may display incompletely when temperature is lower than -10°C, that is because liquid crystal in LCD may freeze in low temperature environment, and LCD will be back to normal when temperature rises back.

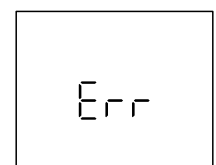

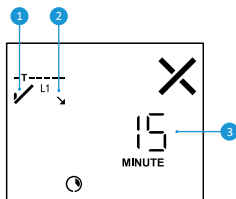

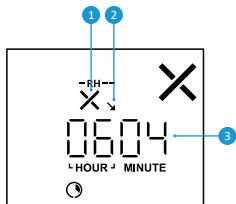

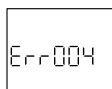

If LCD shows error code like "Err 004" after configuration, please try to re-configure data logger to eliminate error, and you could go to <https://help.tempsen.com> to check more details about error codes.

Important Usage Information

- Please **DO NOT** use the logger if there is no LCD response after being started.
- Data stored in ITAG4 data logger is retrievable after battery exhausted.
- ITAG4 data logger contains lithium battery, please do not heat or recharge it.
- ITAG4 data logger could not be configured again after started.

Battery & Shelf Life

Please check the EXP date (Expiry Date) printed on each logger every time before starting recording, please **DO NOT** use the logger if the EXP date is earlier than current date.

EXP Date: 09/16 (MM/YY)

➤ Expiry date: Sept 30, 2016

Please **DO NOT** connect ITAG4 to PC if you do not plan to use it immediately, first time connecting ITAG4 to PC would turn on power and start consuming battery energy.



After first time connected to PC (no programming performed yet), ⚡ will appear on LCD to remind you that power system is already turned on.

ITAG[®]4 data logger contains one(1) CR2032 lithium metal battery, which passed the Part III, SubSection 38.3 of the UN Manual of Tests and Criteria.

Warranty
